Pack like a pro: Packaging & marking requirements



Air traffic regulations specify that every package must be secure before being loaded on board an aircraft. In order to make sure that your package is secure, warehouse personnel at your shipment's origin must complete a verification of all pieces in your shipment. Since our agent will have to open your package to proceed with the verification, please do not wrap your boxes in special packaging and do not seal them with tape.

Please also ensure that:

- · every shipment contains a packing list of all the items included
- the packaging is durable for air transportation & the shipment is prepared to ensure safe carriage assuming ordinary care and handling
- fragile shipments prone to damage under ordinary care and handling, high or low atmospheric pressure, or changes in temperature are packaged and labelled appropriately
- Styrofoam is not used as a form of outer packaging;
- every piece of the shipment is legibly and durably marked with the name and address of the shipper and consignee
- the packaging of human remains meets all appropriate shipping requirements.
- · all cargo complies with aircraft loading restriction and IATA regulations
- the document and cargo are meeting the requirement of State of Origin, Destination and transit

Shipping requiring Perishables

- To keep your perishable shipment cool and fresh, we recommend using a refrigerant
- Refrigerants should maintain temperature for at least 48 hours
- Use chemical coolants such as dry ice or frozen gel packs for refrigerated shipments
- The maximum amount of dry ice allowed in a package is 5.5 lbs (2.5kg), and it must be shipped in a suitable container. The container should be marked with the words "DRY ICE" and the exact weight of the dry ice (1-5.5 lbs). No Dry Ice of any quantity is allowed on international shipments

Dangerous Goods - Safety is a choice

When transporting hazardous materials, our primary concerns are the safety of people and freight and the well-being of the environment. Please see the IATA Dangerous Goods Regulations or contact us concerning packing group criteria for specific classes of dangerous goods. And kindly note that the shipper must ensure that

- the articles or substances tendered to Condor are not prohibited for transport by air,
- that the articles or substances are properly identified, classified, packed, marked, labeled and documented in accordance with IATA Dangerous Goods Regulations, as well as all government regulations in the countries of origin, transit and destination.

Please kindly note that Condor reserves the right to inspect and/or refuse any consignment presented for shipment.
