

**Dear customer,**

An EU ruling on the securing of infants (children under the age of 2) in aircraft has been in force since July 16, 2008. According to the provisions set out under this directive, infants are to be secured either via a loop belt or child safety seat. Condor recommends particularly for infants the use of an approved child safety seat during the flight. **A reservation can be done monday to friday until 48 hours before departure.
